The MFC buildings are covered as per provisions of Section 11 of Railways Act, 1989 and Paragraph No. 201 of Indian Railways Works Manual, 2000. As such, MFC buildings being developed either by Zonal Railways themselves or through Railway PSUs namely RITES Limited, IRCON International Limited, Rail Vikas Nigam Limited, and Rail Land Development Authority through private builders are to be considered as 'Operational Buildings' of Railways.

2. The duties/responsibility to be discharged by the Zonal Railways, RLDA and PSUs in connection with development of Multi Functional Complexes (MFCs) by RLDA/PSUs are annexed herewith for necessary compliance.
