**TERMS AND CONDITIONS FOR EMPANELMENT OF ADVOCATES AND
LAW FIRMS IN RLDA**

1. The currency of the panel will be two years from the date of notification of panel.
2. The term can be terminated by giving one month's notice by either side.
3. The term can be extended up to one year on the basis of satisfactory performance of the Counsel / Law Firm.
4. If the performance of the Counsel / Law Firm is found to be not satisfactory the name will be deleted from the panel as stated under para.2 above.
5. The Counsel / Law Firms will be required to handle cases in all the Courts/Tribunals within Delhi.
6. The Counsel / Law Firm will give oral and written opinion on issues relating to the business of RLDA which are referred to them.
7. The Counsel / Law Firm will have to give legal vetting of tenders, contracts, due diligence of land records, documents related to the transaction of business of RLDA and referred to them by the RLDA.
8. The Counsel / Law Firm will have to Draft Legal documents in connection with the business of RLDA.
9. The Counsel / Law Firm will have to participate in discussion / conference on behalf of RLDA and with their clients wherever necessary.
10. During the Term of Empanelment and thereafter the Law Firm / Advocate shall maintain strict confidentiality of the matters pertaining to the RLDA. They shall not accept briefs against the RLDA during the term of empanelment.
11. The Counsel / Law Firm shall not advise any party or accept any case against the RLDA in which he has appeared or is likely to be called upon to appear for or advise in any case which is likely to affect or lead to litigation by / against RLDA.
12. The Counsel / Law Firm will neither divulge any information received by him from the RLDA, as empanelled Firm/ Lawyer nor shall disclose any instructions given to him, by the RLDA from time to time.

13. The allotment of case / matter will be done as per the discretion of the Competent Authority, for which the Counsel /Law Firm will have no right or claim whatsoever.
14. The case may be withdrawn from any Counsel / Law Firm and can be assigned to another Counsel / Law Firm without assigning any reason.
15. The Counsel / Law Firm shall apply for and obtain certified copy of every judgement or order, immediately after the said judgement / order is passed and shall transmit the same to Joint General Manager(Law)of the RLDA without any delay, along with his detailed opinion on the possibility of challenging the judgement/order. In case, the said judgement/order is challengeable by RLDA, the Counsel / Law Firm shall keep in mind the period of limitation.
16. The Counsel / Law Firm shall submit report of court cases to the Joint General Manager(Law) of the RLDA after each hearing and specific note regarding order passed by the Court and stay/injunctions granted or extended against the RLDA, immediately along with copy of order passed by the Court.
17. The Counsel / Law Firm will keep the Joint General Manager(Law) informed in writing of the important proceedings/development in the cases from time to time particularly with regard to the drafting /filing of papers and implementation of courts directions. The Counsel / Law Firm will be expected to take initiative to ensure that W.S .and Affidavits are filed in time.
18. In such important cases where Senior Advocates have been engaged the Counsel / Law Firm shall attend the conference to brief the Senior Advocate.
19. If any misc. application is filed in the Court by any person against the RLDA, the Counsel/ Law Firm shall seek instructions from the concerned offices of the RLDA before making submission in the Court.
20. On the expiry/termination of term, the Counsel / Law Firm will return all files/documents to RLDA.
21. Payment of fees will be at the rates notified by RLDA under O.O No.5/Law/2013 dated 05.08.2013. (Annexure-II).
