**FOR KIND ATTENTION OF APPLICANTS WHO HAVE APPLIED FOR THE POST OF
ASSISTANT PROJECT ENGINEER (CIVIL) ON CONTRACT BASIS AGAINST VACANCY
NOTICE NO. RLDA/CONTRACT/2021/02**

After preliminary scrutiny of applications received against vacancy notice no. RLDA/Contract/2021/02, list of **REJECTED** and **PROVISIONALLY ACCEPTED** applications was uploaded on RLDA's official website rlda.indianrailways.gov.in and grievances were called for from 14.02.2022 to 21.02.2022. Total 16 grievances were received through the given email id (psecontract@gmail.com) and action taken thereon was notified vide this office Notice no. 03/2022 dt. 02.04.2022. As the GATE score card does not indicate 'Percentile', formula for deriving 'Percentile' was also notified vide Notice no. 03/2022 and complete list of all the provisionally accepted applications indicating percentile was notified.

2. Against the 45 notified vacancies, a list of top 45 applicants and 20% extra applicants as waitlisted applicants, i.e., total 54 applicants were called for verification of documents held on 11.04.2022, 12.04.2022 & 13.04.2022 (for absentees) when only 20 applicants appeared. Candidature of rest 34 applicants is hereby cancelled.

3. All the 20 applicants who appeared for document verification were sent for medical examination out of which 03 remained non-responsive and have shown their unwillingness to proceed further for their engagement in RLDA. Also, their medical reports have yet not been received. Candidature of these 03 applicants is also hereby cancelled. Provisional offer letters to the rest 17 applicants who have been found medically fit, have already been issued through email, Whatsapp & Speed Post with advice to attend the training commencing from 23.05.2022.

4. Now, to fill up the balance 28 vacancies, a list of next 34 applicants (28 + 20% extra) is attached. These 34 applicants are required to attend the document verification process as per schedule and place indicated in Annexure – I. However, the final intake shall be 45 only in terms of notified criteria of selection process (item no. 4 of the vacancy notice) with no further commitment, as such, that in case of non-turn-up of these applicants/shortfall, any number of applicants below the above number of applicants, shall be called for.

5. NO TA/DA or any type of expenditure, loss of any kind, whatsoever, to the applicants appearing for verification of documents, shall be paid/bear by RLDA.

6. Calling for document verification does not imply that the applicant has been selected for engagement in RLDA against the referred vacancy notice.

7. For the candidates appearing for document verifications no arrangement for journey, stay or any other eventuality shall be made by RLDA and candidates should manage and bear the expenditure themselves.

8. For any Legal matters the jurisdiction will be at Delhi.
