

Desirable:	1. One year PGDCA (from AICTE/UGC recognized institution). 2. Maintenance/Development of payroll. 3. Experience in preparing technical specification for IT related infrastructure. 4. Installation monitoring and use of network management system. 5. Procurement through GeM. 6. Working as administrator in e-office.
